3. PAGE A-00, PROVIDE A SQUARE FOOTAGE BREAK DOWN OF THE FOLLOWING BUILDING AREAS: EXISTING RESIDENCE, NEW ADDITION, EXISTING FRONT COVERED PORCH, NEW COVERED TERRACE, EXISTING CARPORT, AND NEW POOL.

4. ON THE FINAL PLAN SET, PROVIDE A LANDSCAPE PLAN SHEET, INCLUDE, AN EXISTING LANDSCAPE SITE PLAN, TREE PROTECTION DETAILS, NEW LANDSCAPE SITE PLAN (IF APPLICABLE), AND A PLANT AND TREE SCHEDULE. ARTICLE 5, SECTION 5-1105, B.

5. PAGE A-00, LOT SIZE DIAGRAM, PROVIDE THE SIDE YARD OPEN LANDSCAPE SQUARE FOOTAGE ON EACH SIDE (MINIMUM REQUIRED 250 SQ. FT. ARTICLE 5, SECTION 5-503, A., #1
