**RESOLUTION NO. 2025-63**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE ACCEPTANCE OF A THIRD AMENDMENT TO GRANT NO. C2207 WITH THE STATE OF FLORIDA, DEPARTMENT OF ENVIRONMENTAL PROTECTION, EXTENDING THE AGREEMENT PERIOD BY THIRTEEN MONTHS, FROM JUNE 30, 2025, TO JULY 31, 2026, FOR THE CORAL GABLES SANITARY SEWER COASTAL BAY SERVICE AREA GRANT, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDMENT FOR THE FINANCIAL ASSISTANCE.

**WHEREAS**, on May 9, 2023, the City Commission accepted a competitive grant award from the State of Florida Department of Environmental Protection (DEP) for the Coral Gables Sanitary Sewer Coastal Bay Service Area Rehabilitation Water Project in the amount of \$2,000,000 for the repairing and/or replacing of its existing gravity sanitary sewer pipe system in the areas of Cocoplum, Gables Estates, and Gables by the Sea neighborhoods; and

**WHEREAS**, the previous amendment to this contract was made for statutory language updates requested by the DEP; and

**WHEREAS**, the City requested an extension due to delays in the project, which was granted by the DEP; and

**WHEREAS**, the total project cost is \$2,500,000, with \$2,000,000 from the grant and \$500,000 in required matching funds from the City of Coral Gables.; and

**WHEREAS**, the City Commission authorized the City Manager to execute any future extensions, amendments, or modifications to grant agreement no. C2207 with DEP;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.


**SECTION 2.** The City Commission does hereby authorize the acceptance of the third amendment to grant no. C2207 for a thirteen-month extension.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.


