are in violation of the following sections of the City Code of the City of Coral Gables:

Defacement of trees, shrubs, vines, etc. Folio #, 0341200231440 Permits generally(e) - Pruning on public property - Sec. 82-3. - Defacement of trees, shrubs, vines, etc., in public places prohibited

(a) Violations of this section shall be punished as provided in section 1-7 (b) No person shall, without a written permit from the city manager and director of public service, cut, prune, break, incline, injure, remove or in any other way deface any living tree, shrub, orchid, or vine, in a public street, city right-of-way, or park, or cut, disturb or interfere in any way with the roots of any tree, shrub, orchid, or vine in a public street, city right-of-way, or park, care in any way with the roots of any tree, shrub, orchid, or vine in a public street, city right-of-way, or park.

(e)Pruning of trees on public property and rights-of-way. The pruning of any trees on public property and rights-of-way is prohibited unless expressly approved by the tree preservation agency in advance. (Ord. No. 2017-45, § 2(Att. A), 12-5-2017)

Code Enforcement Officer Comments: Over Pruning of 3 oak trees on private property and 3 on public right of way. City Arborist Jorge Rivera on site. Over pruning of 3 oak trees on private property over pruning of 3 oak trees on public right of way by All Smooth Landscaping and Lawn Service hired by condo.

The following steps should be taken to correct the violation:

Remedy:

Must obtain a written permit from the city manager and director of public service - stop all work without approval.

Obtain all necessary permits as per Chapter 82-29 - STOP ALL PRUNING - must obtain approval for pruning of trees on public right of way - trees on private property must be pruned properly.

As a result of the above violation(s), a complaint has been filed against you and you are hereby commanded to appear before the Code Enforcement Board for a hearing on 11/16/2022 at 8:30AM in the Commission Chambers, located on the second floor of:

Development Services Center 427 Biltmore Way Coral Gables, FL 33134

This is your notice to appear at said time and place. Failure to do so will result in the matter being heard in absentia. An administrative fee of \$108.75 will be assessed at the time of your hearing.

Please be advised that if someone will be attending the hearing on your behalf, he or she must provide a power of attorney from you at the time of the hearing

If this notice pertains to failure to maintain a historic structure, please be advised that:

- You may be subject to substantial fines that may not be mitigated.
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
 - the City Code requires that you replace the structure with a similar historically-appropriate structure; and
 - the property will no longer qualify for an historic preservation tax exemption.
