DRAFT RESOLUTION

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE PARKING CASHIERS, ATTENDANTS, AND SUPERVISORS FOR THE CITY'S PARKING FACILITIES CONTRACT TO LAZ FLORIDA PARKING LLC, PURSUANT TO REQUEST FOR PROPOSALS (RFP) 2014.06.19, AND SECTION 2-828 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on June 24, 2014, the Procurement Division of Finance formally advertised, issued, and distributed the Parking Cashiers, Attendants, and Supervisors for the City's Parking Facilities RFP 2014.06.19; and

WHEREAS, on July 8, 2014, a non-mandatory pre-proposal conference was held with eight (8) prospective proposers in attendance of the twenty-one (21) prospective proposers who obtained the RFP package from the Procurement Division; and

WHEREAS, on July 31, 2014, three (3) proposals were received in response to RFP 2014.06.19 from Faneuil, Inc., SP+ Municipal Services, and LAZ Florida Parking LLC; and

WHEREAS, on August 19, 2014, the Evaluation Committee convened and participated in question and answer sessions with each of the proposers, discussed, evaluated, scored and ranked the proposals and determined that LAZ Florida Parking LLC was the most responsive and responsible proposer offering the most comprehensive and customer service driven solution to the City; and

WHEREAS, a Notice of Intent to Protest was filed on September 8, 2014, followed by a Written Protest on September 15, 2014 by another RFP Proposer, SP+ Corporation; and

WHEREAS, the City Attorney, at the request of the Chief Procurement Officer, in accordance with City Code Section 2-950(g), reviewed the award and opined that the award to LAZ Florida Parking, LLC was legally sufficient; and

WHEREAS, on September 24, 2014, the Chief Procurement Officer submitted a Recommendation To Deny The Protest in response to the Written Protest to the City Manager, and in concurrence with that recommendation the City Manager submitted same to the City Commission for approval; and

WHEREAS, the City Commission has reviewed the Recommendation to Deny the Protest and approves said recommendation upholding LAZ Florida Parking, LLC as the most responsive and responsible proposer, and awarding the firm the Parking Cashiers, Attendants, and Supervisors for the City's Parking Facilities contract.

NOW THEREFORE BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Parking Cashiers, Attendants, and Supervisors for the City’s Parking Facilities contract to LAZ Florida Parking LLC, pursuant to Request for Proposals (RFP) 2014.06.19, and Section 2-828 of the Procurement Code entitled “Contract Award”, subject to final approval and execution of a contract by City staff.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
