Presentation of \$1,610.22 donation from the City of Coral Gables to the Fundación Unidos por un Sueño collected during the "Holiday Sip and Shop on Miracle Mile" event.

The City of Coral Gables presented a donation to Fundación Unidos por un Sueño, a nonprofit organization based in Uruguay and Miami, which provides joyful experiences for children battling cancer by bringing them to Orlando theme parks. The funds were raised during the city's "Holiday Sip and Shop" event on Miracle Mile, held on November 20, 2025. The event featured curated wine tastings and retail promotions, with wine donated by the Consulate of Uruguay. Leticia Zambrana, the foundation's president, expressed heartfelt gratitude to the city, Mayor Lago, and the Economic Development Department for their support. She emphasized the importance of community collaboration in helping children who have overcome cancer. Mayor Lago praised the initiative, highlighting its emotional impact and the importance of giving during the holiday season. The Consul of Uruguay, Rafael Villamor, also thanked the city for its partnership and support.

Presentation of a Proclamation declaring December 9, 2025 as "Actors' Playhouse Day" in Coral Gables.

Mayor Lago proclaimed December 9, 2025, as Actors' Playhouse Day in Coral Gables, celebrating the 30th anniversary of the Miracle Theater's reopening under the leadership of Actors' Playhouse. Founded in 1988 by Dr. Lawrence and Barbara Stein, the theater moved to Coral Gables in the early 1990s through a public-private partnership and a \$10 million capital campaign that saved the historic Miracle Theater from commercial redevelopment.

Barbara Stein, joined by her team and former Mayor Dorothy Thompson, reflected on the theater's journey and its cultural and economic contributions to the city. She highlighted the theater's extensive programming, including over 200 main stage and children's productions, youth conservatories, and community outreach. Stein also announced a campaign to replace the theater's 600 seats and ongoing capital improvements. Former Mayor Thompson recounted her initial meeting with Stein and her decision to sponsor the proposal that led to the theater's establishment. Commissioners praised the theater's impact on downtown revitalization, tourism, and cultural enrichment. The proclamation recognized the theater's enduring legacy and its role as a cornerstone of Coral Gables' arts scene.

Presentation of a Proclamation declaring December 10, 2025 as "Jesus Permuy Day" in Coral Gables.

Mayor Lago proclaimed December 10, 2025, as Jesus Permuy Day in Coral Gables, honoring his 90th birthday and lifetime of civic, cultural, and humanitarian contributions. Permuy was a prominent Cuban resistance leader, serving in the Movimiento de Recuperación Revolucionaria (MRR) and later founding the Human Rights Center of Miami in Coral Gables. His advocacy reached international institutions, including the UN, OAS, and Amnesty International. Permuy also played a key role in preserving Coral Gables neighborhoods through his work as a HUD Planning Division Supervisor, notably in the Golden Gate and McFarland Homestead areas. He founded one of the first Cuban art galleries in the U.S., helping establish Coral Gables as a hub for Latin American art. During the presentation, Permuy humbly thanked the city and shared memories of his work in urban rehabilitation. Mayor Lago and commissioners praised his legacy, courage, and the admiration shown by his family. The proclamation recognized Permuy's contributions to democracy, human rights, and the cultural fabric of Coral Gables.

He emphasized that the recognition belongs to his team of financial advisors and expressed deep appreciation for his wife and brother. Mayor Lago and commissioners commended Hernandez's humility, dedication to Coral Gables, and commitment to giving back. His business has been based in Coral Gables since 1999, and his home, built in 1925, celebrates its centennial this year.
