**ARBOR DAY:** The arrangements were confirmed. The event was scheduled for Friday, April 11, 2014 at Coral Bay Park, 1590 Campamento Ave. The speaker of the Children’s program will be Kathy Gaubatz. Mr. Zamek will invite with the Growing Place Kindergarten Class. The speaker for the Main Presentation is pending. There are two options; Ms. Perez will reach out to Gulliver Academy and Ms. Murff will reach out to Fairchild Tropical. One will be selected at the March 6<sup>th</sup> meeting. Ms. Fulks will look into the Boys Scouts leading the Pledge of Allegiance. The event agenda was reviewed. The Children’s Program will begin at 10:30 am. Ms. Martin-Lavielle, Master of Ceremony, will give a Welcome/Introduction at 11:00 am. The Boy Scouts will lead the Pledge of Allegiance. Ms. Martin-Lavielle will acknowledge the Dignitaries. Mr. Zamek will introduce the Landscape Beautification Advisory Board. The Garden Club will be introduced and they will present a brief history of Arbor Day. The Main Presentation will take place. It should be a 15 to 20 minute presentation with an additional 5 to 10 minutes for questions. The Mayor will present the Proclamation. Ms. Keller will confirm the Mayor’s attendance. Greenway Dr., 4815 San Amaro Dr. Ms. Perez advised that she was not allowed into Journey's End for her initial nominations. In the future, the Journey's End Association should be notified to ensure that their properties can be considered for this award.
