Solanch Lopez, Business Community Manager - Economic Development presented the winners of the 2025 Holiday Window Contest, an annual initiative encouraging downtown merchants to decorate their storefronts during the holiday season to enhance the city's festive atmosphere. Each winner received a \$300 prize. The presentation outlined the rigorous evaluation process, which requires trend data and comparative analysis, and discussed next steps for applying for the national award. The Mayor and City Commissioners commended Ms. Perez, Baptist Health, the Chamber of Commerce, and other partners for their dedication to maintaining Coral Gables' reputation for excellence.
