

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2025-85**

A RESOLUTION OF THE CITY COMMISSION, ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL ELECTION, WHICH WAS HELD ON APRIL 8, 2025, WHEREIN VOTERS RE-ELECTED RHONDA ANDERSON, TO HOLD OFFICE AS CITY COMMISSIONER GROUP II, FOR A TERM OF FOUR YEARS; SAID TERM TO BEGIN AT NOON ON THE THIRD DAY AFTER THE ELECTION, UNTIL NOON ON THE THIRD DAY AFTER THE GENERAL BIENNIAL ELECTIONS SCHEDULED FOR APRIL 10, 2029.

**WHEREAS**, on April 8, 2025, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables General Biennial Election, the Miami-Dade Elections Department counted the votes cast for those candidates who sought to hold office for City Commissioner (Group II); and

**WHEREAS**, the tabulation of vote count of the total ballots cast yielded the following results:

Rhonda Anderson	5,825	58.24%
Laureano Cancio	0,447	04.47%
Felix Pardo	3,730	37.29%

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby accept the City Clerk's Certification and Declaration of the Result from the Coral Gables General Biennial Election (2025), and made a part of this Resolution, in connection with the re-election of Rhonda Anderson, to the position of City Commissioner, Group II, for a four-year term to begin at noon on the third day after the election, until noon on the third day after the General Biennial Election scheduled for April 10, 2029.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


