**BRIEF HISTORY:**


This is a special event request for Fritz and Franz Bierhaus to celebrate *OKTOBERFEST* in Coral Gables. This request is to serve alcoholic beverages during the celebration and is in compliance with the laws of the State of Florida.

In regard to *OKTOBERFEST* hours, they will open during the week from 11:00 a.m. until midnight and on the weekends from 11:00 a.m. until 2:00 a.m. They will not have live music outdoors during the week unless part of a private party, which will end at 10 p.m. In addition, a code enforcement officer will be on hand to supervise the noise level of the event. The officer will keep communication with central dispatch, will be aware of any noise complaints made and will take any steps needed to manage the noise level.

Live music on weekends will end at 10 p.m outdoors and possibly move indoors until 1:00 a.m. On Sundays music will stop at 8:00 p.m.
