**ITEM TITLE:**

**Resolutions.** Consideration of **Application No. 07-08-072-P**, consisting of the following items:

- 1. Separation of building site.** A Resolution of the City Commission of Coral Gables approving a separation of a building site pursuant to Zoning Code Section 12-5, into three (3) separate building sites consisting of two (2) new single-family residential building sites and one (1) existing duplex building site, legally described as Lots 8-15, Block 6, Coral Grove Section (1800 LeJeune Road), Coral Gables, Florida; as set forth in Application No. 07-08-072-P; and providing for an effective date (see Exhibit A).
- 2. Final plat – "Pilafian Properties".** A Resolution of the City Commission of Coral Gables approving final plat entitled "Pilafian Properties" being a re-plat of an approximately 0.7 acre site into three (3) platted lots, legally described as Lots 8-15, Block 6, Coral Grove Section (1800 LeJeune Road), Coral Gables, Florida; as set forth in Application No. 07-08-072-P; and providing for an effective date (see Exhibit B).

**PLANNING DEPARTMENT RECOMMENDATION:**

Recommendation for approval of the proposed building site separation and tentative plat entitled "Pilafian Properties" with the recommended conditions of approval contained in the attached Resolution (see Exhibit A). The recommendation for approval is based on the findings of fact provided in this memorandum and associated supporting documents.


