**RESOLUTION NO. 2023-210**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING ACCEPTANCE OF A FLORIDA DEPARTMENT OF STATE, DIVISION OF ARTS AND CULTURE, SPECIFIC CULTURAL PROJECT GRANT IN THE AMOUNT OF \$25,000 TO BE PUT TOWARD AN OUTDOOR PUBLIC ART EXHIBITION; AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2022-2023 ANNUAL BUDGET TO RECOGNIZE THE \$25,000 GRANT AS REVENUE AND TO APPROPRIATE SUCH FUNDS TO COVER THE GRANT EXPENDITURES.

**WHEREAS**, the City was awarded a competitive Florida Department of State, Specific Cultural Project Grant in the amount of \$25,000 toward an outdoor public art exhibition; and

**WHEREAS**, the grant requires at least one dollar in cash or in-kind (donated goods or services) for every dollar requested from the Division; and

**WHEREAS**, staff recommends use of Art Fund monies to meet the requirement of matched dollars; and

**WHEREAS**, an amendment to the Fiscal Year 2022-2023 Annual Budget is required to recognize the \$25,000 grant as revenue and to appropriate such funds to cover the grant expenditures;

**NOW, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.


**SECTION 2.** The City Commission does hereby authorize the acceptance of a Florida Department of State, Specific Cultural Project Grant in the amount of \$25,000 toward an outdoor public art exhibition.

**SECTION 2.** The City Commission does hereby authorize use of Art Acquisition Fund monies to meet the requirement of matched dollars.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


