**RESOLUTION NO. 2022-256**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE BODY WORN CAMERAS CONTRACT RFP 2021-050 TO AXON ENTERPRISE, INC., THE RESPONSIVE-RESPONSIBLE PROPOSER, PURSUANT TO SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED “CONTRACT AWARD”.

**WHEREAS**, on February 22, 2022, the Procurement Division of Finance formally advertised, issued and distributed RFP 2021-050; and

**WHEREAS**, on April 4, 2022, three (3) proposers submitted proposals in response to the RFP: Axon Enterprise, Inc., Motorola Solutions, Inc., and Utility Associates, Inc; and

**WHEREAS**, on May 18, 2022, the Evaluation Committee convened to evaluate the one (1) responsive and responsible proposal. The Evaluation Committee determined that Axon Enterprise, Inc., is a responsive-responsible proposer; and

**WHEREAS**, the Chief Procurement Officer recommends accepting the Evaluation Committee’s recommendation to award and negotiate an agreement with Axon Enterprise, Inc., for RFP 2021-050 Body Worn Cameras; and

**WHEREAS**, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**


**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The City Commission accepts the recommendation of the Chief Procurement Officer to award the Body Worn Cameras contract RFP 2021-050 to Axon Enterprise, Inc., the responsive-responsible proposer, pursuant to Section 2-763 of the Procurement Code entitled “Contract Award”, further authorizing the City Manager to negotiate and execute a Professional Services Agreement for an initial period of five (5) years with the option to renew for two (2) additional five (5) year periods, exercisable at the option of the City Manager in an amount not to exceed the available budget.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


