**RESOLUTION NO. 2011-287**

**RESOLUTION APPROVING THE FISCAL YEAR 2011-2012 CULTURAL GRANTS.**

**WHEREAS**, one of the responsibilities of the City's Cultural Development Board is to recommend to the City Commission the annual allocation of cultural grant funding; and

**WHEREAS**, on November 16, 2011, the Board reviewed and scored 24 applications for City of Coral Gables Cultural Development Grants; Cultural Series, Festivals, & Special Events Grants; and Community Grants; and

**WHEREAS**, six additional applications were disqualified for not meeting grant requirements and four applications are recommended to not be funded because of a low score; and

**WHEREAS**, recommended funding of the remaining 20 applications are shown in Exhibit A: FY2011-12 Cultural Grants – Allocation Recommendations, which Exhibit is attached hereto and made a part hereof;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to fund the Cultural Grant awards in the grant categories of Cultural Development; Cultural Series, Festivals & Special Events; and Community, in the total amount of \$75,000, to applicant organizations in the amounts as is more specifically set forth in Exhibit A.

**SECTION 3.** That this resolution shall become effective immediately upon the date of its passage and adoption herein.
