No person shall commence or cause to be commenced any miscellaneous work, which does not otherwise require a building permit, which affects the aesthetics, appearance, or architectural design of any structure, site or site improvements until an application for a zoning permit therefore has been previously filed with the Building Division. No such miscellaneous work which affects the aesthetics, appearance, or architectural design of any structure, site or site improvements shall commence until a permit has been issued by the City.

 - 2. The Respondent(s) shall correct the violation/s.
 - 3.If the violation(s) are not corrected by $\underline{11/20/2021}$, a fine of $\underline{\$250.00}$ will be imposed for each day thereafter that any violation continues to exist.
 - 4.If the Respondent(s) does (do) not comply within the time specified, a certified copy of this Order shall be recorded in the Public Records of Miami-Dade County and thereafter SHALL CONSTITUTE A LIEN against the property upon which the violation(s) exist or upon any real and personal property of the violator.
