## **RESOLUTION NO.**

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND CONTRACT NO. RFP 2019-008 FOR DISASTER DEBRIS MONITORING SERVICES (ADDITIONAL LEVELS OF SERVICE) WITH GOODWYN MILLS CAWOOD, LLC, PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS."

WHEREAS, the City and Witt O'Brien's previously entered into a Professional Services Agreement effective March 13, 2020, ("Agreement"), for Disaster Debris Monitoring Services (Additional Levels of Service) RFP 2018-001 ("Services"); and

**WHEREAS**, on October 1, 2024, the City approved an assignment of all of Witt O'Brien's, LLC rights, title, interest, and obligations in and to the Agreement to Goodwyn Mills Cawood, LLC; and

**WHEREAS,** the Parties desire to extend the Agreements from May 22, 2025 until November 30, 2025 to coincide with the end of the Hurricane Season.; and

**WHEREAS,** contract changes are allowable by FEMA as long as documented procurement policies and procedures are followed pursuant to 2 C.F.R § 200.317; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on change orders and contract modifications; and

## NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**Section 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to extend contract RFP 2019-008 for Disaster Debris Monitoring Services (Additional Levels of Service) until November 30, 2025, pursuant to section 2-764 of the procurement code entitled "Approval of Change Orders and Contract Modifications".

Section 3. That this resolution shall become effective upon the date of its adoption herein.
