Chairman's Report

• Speed limit on Lejeune

- o The Board discussed lowering the speed limit on Lejeune. Staff advised that Lejeune is not in their purview.
- Feedback from Miami-Dade County regarding the pedestrian walkway on Ponce Park and why it wasn't approved in the middle section of the park.
 - Staff advised that this was a discussion that occurred before their time. However, it did
 not work well for safety. The trolley stops are located midblock and it's safer for
 pedestrians to cross at the intersection.

Signal timing duration in Coral Gables

o David asked the Board about his request for suggested intersections for signal retiming.

Police Update:

Annual traffic calming studies and traffic monitoring for the Paseo Project

 Staff advised that the monitoring had paused due to the pandemic, studies and monitoring will resume for the next years. However, traffic has not increased to pre-pandemic levels. Henry stated that he feels the data may be faulty and would like resident happiness to be taken into consideration.
