**RESOLUTION NO. 2008-08**

A RESOLUTION ACCEPTING THE RESPONSE TO REQUEST FOR PROPOSAL NO. 2007-10-04, TROLLEY PROGRAM MAINTENANCE SERVICES, FROM FIRST VEHICLE SERVICES, INC. (FVS), THE SOLE RESPONDENT TO SAID REQUEST FOR PROPOSAL; AUTHORIZING THE CITY MANAGER TO NEGOTIATE A NEW CONTRACT WITH FVS; AND FURTHER AUTHORIZING THE CITY MANAGER TO EXTEND THE CURRENT CONTRACT WITH FVS ON A MONTH-TO-MONTH BASIS AT THE CURRENT RATE UNTIL AN ACCEPTABLE CONTRACT IS NEGOTIATED.

**WHEREAS**, upon duly following the requirements of the procurement code and after two solicitations for requests for proposal for trolley program maintenance services, a sole response to RFP No. 2007-10-04 was received by the City from First Vehicle Services, Inc. on November 15, 2007; and

**WHEREAS**, after extensive research in reviewing firms available to provide the services requested in said request for proposal, it has been determined that FVS is the best available vendor to perform these services; and

**WHEREAS**, pricing included in said RFP response exceeds the current amount budgeted in the FY 2007-2008 budget and will need to be negotiated and adjusted prior to the preparation of a new acceptable contract; and

**WHEREAS**, the current contract with FVS has expired and there is a need to extend this contract on a month-to-month basis at the current rate until an acceptable negotiated contract is executed;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The sole response to Request for Proposal No. 2007-10-04, Trolley Program Maintenance Services, from First Vehicle Services, Inc. is hereby accepted.

**SECTION 3.** Based on the accepted response to Request for Proposal No. 2007-04-10, the City Manager is hereby authorized to negotiate a new acceptable contract with First Vehicle Services, Inc.

**SECTION 4.** The City Manager is hereby authorized to extend the current contract with First Vehicle Services, Inc. on a month-to-month basis at the current rate, until an acceptable negotiated contract is executed.

SECTION 5. This Resolution shall become effective upon the date of its passage and adoption herein.


