# F.1.- AiPP UPDATES

The Panel was updated on the following public art projects.

- Proposals approved by the CDB and City Commission:
  - "Dear Human", a public art and poetry project in partnership with O, Miami and the Lowe Art Museum, running through the month of April with an event on April 12<sup>th</sup> at 427 Biltmore Way.
  - 2. "The Water Below Us", a temporary public art and water awareness project on Giralda Plaza in partnership with Blue Mission, opening on World Water Day, March 20th. The project includes an Augmented Reality (AR) component and will be exhibited for two months.
- Centennial Commemorative Public Artwork Proposals are published and available for public comment on the city's public art webpage.
- Janine Antoni and Julio Larraz commissions are moving forward.
