A RESOLUTION OF THE CITY COMMISSION AMENDING THE FISCAL YEAR 2021-2022 AMENDED ANNUAL BUDGET TO RECOGNIZE AS REVENUE 1ST QUARTER CORAL GABLES IMPACT FEE RECEIPTS AS WELL AS PRIOR YEAR RECEIPTS (UNDERLINE), AND TO APPROPRIATE SUCH FUNDS TO PUT TOWARD THE COST OF CAPITAL IMPROVEMENT INFRASTRUCTURE PROJECTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in compliance with Ordinance No. 2007-27 as well as the revised impact fee schedule as approved by Resolution No. 2017-67, the City collects various impact fees to help fund capital improvement projects that qualify as enhancing services for residents, business owners and visitors; and
