OFFICER OF THE MONTH – OFC. DASHIELL GARCIA

I respectfully nominate Officer Dashiell Garcia (ID #11047) for the Officer of the Month Award for March 2021.

On March 10, 2021 at approximately 0231 hours, CGPD Communications received a 911 call from the CVS store located at 1160 South Dixie Highway (US-1), Coral Gables, Florida about a theft in progress (27). A CVS employee stated three (3) white females stole wine and makeup, then fled in a gray hatchback bearing Florida tag LZBQ55. The 911 caller was still on the phone with the call taker as he watched the vehicle flee eastbound on US-1, then make a right-hand turn, heading southbound, possibly onto Augusto or Maynada Street. Both streets lead into residential neighborhoods.

Communications personnel announced a BOLO for the three female subjects and the vehicle over the police main radio channel to all on-duty officers. Officer Dashiell Garcia (ID #11047) was assigned by the dispatcher as the primary unit since the theft occurred in his assigned zone. However, he was responding from a distance since he had just finished conducting a Directed Patrol in the City's South District (Zone 11 Blitz).

Officer Garcia knew there was a very good chance of locating the subject vehicle due to the very short time delay from the when the theft occurred, and the BOLO being announced over the radio. Officer Garcia's intuition also told him that the subjects turned off US-1 to avoid detection and escape to the City of Miami by traversing eastbound through Coral Gables residential neighborhoods.

While responding to the call, Officer Garcia demonstrated good knowledge of surrounding jurisdictions geography by taking a shortcut through High Pines and heading North on Ponce De Leon Road (Miami-Dade County). As he approached the intersection of Maynada Street and Sunset Road, he demonstrated good judgement and decision making by heading northbound on Maynada Street, since the subject vehicle was last seen turning South in his direction. As Officer Garcia drove North on Maynada Street, he noticed vehicle headlights coming toward him from a distance. The vehicle then turned left onto Hardee Road heading eastbound. Officer Garcia accelerated his patrol vehicle to catch up with the vehicle on Hardee Road, and noticed that it matched the BOLO description provided by the dispatcher. He also noticed that it was occupied by three white females and it had the same license tag number. Additionally, Officer Garcia

noticed the tag had a more than six (6) month expired registration decal, a criminal traffic violation.

Officer Garcia conducted a traffic stop on the subject vehicle for the expired registration violation at the intersection of Hardee Road and Riviera Drive and waited for his backup, Officer Bryan Maizo to arrive. I (Sergeant Paul Koppel) arrived on scene shortly thereafter and was very impressed as I observed Officer Garcia conduct a very professional and thorough traffic stop and subsequent criminal investigation. Officer Garcia removed all three subjects from the vehicle, then separated and temporarily detained them with Officer Bryan Maizo's assistance, before beginning his investigation.

Officer Garcia demonstrated very good knowledge and utilization of available resources by delegating ancillary tasks such as obtaining victim/witness statements, conducting a show up, processing both crime scenes, impounding evidence and returning stolen property to the owner, CVS. Once Officer Garcia determined there was probable cause to make an arrest, he read Miranda warnings to each subject individually and attempted to obtain further incriminating statements and/or confessions from them. The Incident/Investigation Report that Officer Garcia submitted was also outstanding (Ref. CGPD Case #21001339). It was complete, detailed and well written, with no corrections needed upon my supervisory review.

I, Sergeant Koppel, have had the pleasure of being Officer Dashiell Garcia's direct supervisor since January 2021. In this short time, Officer Garcia has quickly demonstrated that he's a competent and professional law enforcement officer. He's also a team player who will gladly help his fellow officers without ever being asked to help.

For these reasons, I respectfully recommend that Officer Dashiell Garcia be considered for the prestigious Officer of the Month Award for March 2021.

NARRATIVE

On March 10, 2021 at approximately 0231 hours, I was dispatched to 1160 South Dixie Highway (CVS) in reference to a theft in progress. CVS Loss Prevention Officer, Mr. Gustavo Maglio (Reporting Party) advised that three white female subjects stole wine and make-up items from the store and fled eastbound on S. Dixie Hwy toward Ponce De Leon Middle School, in a silver 4-door hatchback Chevrolet, bearing Florida tag LZBQ55.

According to Mr. Maglio, and the video surveillance footage, the three females walked into CVS at approximately 0228 hours, one at a time, a few seconds apart and all three went their separate ways inside the store. Ms. Brianna Del Val (Offender 1) walked toward the wine section of the store. Ms. Janette M. Alen (Offender 3) proceeded to the cosmetics aisle. And Ms. Nathalie S. Fuentes (Offender 2) began to engage Mr. Maglio in conversation, in an attempt to conceal the actions of Ms. Del Val and Ms. Alen. Mr. Maglio stated that Ms. Del Val selected and concealed 2 bottles of "Korbel Brut" champagne (\$15.99 each) inside her bag and walked past all points of sale without making an attempt to pay for the merchandise. Mr. Maglio confronted Ms. Del Val outside of the store and asked her to return the property she stole. Ms. Del Val complied with Mr. Maglio's request, and handed over the 2 bottles of Korbel. During this interaction, Ms. Alen remained inside the store with two items in hand; an oil free rose serum (\$17.79) and a skin boost hydration (\$14.99). Ms. Alen placed those two items on top of a display inside the store and fled. Ms. Alen did not walk past all points of sale with the merchandise in hand.

All three Offenders jumped inside the silver 4-door Chevrolet Sparks and fled eastbound on the 1100 block of S. Dixie Hwy. Mr. Maglio observed the fleeing vehicle make a right turn from S. Dixie Hwy onto Augusto Street. According to the subject vehicle's direction of travel and my location at the time, I started to canvass the area traveling eastbound on Hardee Road. I observed a vehicle traveling eastbound on the 900 block of Hardee Road and I sped up to get a closer look at that vehicle, which matched the description and tag information provided by Mr. Maglio. I also observed that the silver Chevrolet Sparks had an expired tag.

I conducted a traffic stop on the aforementioned vehicle at the intersection of Hardee Rd and Riviera Dr. The vehicle was occupied by three females (driver, front passenger and rear passenger). I made contact with the driver of the vehicle, Ms. Alen, who identified herself via her Florida Drivers' License. The front passenger and rear passenger of the vehicle stated that they did not have an identification card with them at the time of the incident.

During the course of the investigation and while lawfully detained by law enforcement officer, the front passenger subject provided her personal information verbally and identified herself as Ms. Brianna Del Val. The rear passenger subject provided the name "Natalie Rodrigues" and a date of birth of 11/21/1998. Further investigation revealed that the real name of "Natalie Rodrigues" is Ms. Nathalie Sofia Fuentes and her date of birth is 11/11/1999. Ms. Fuentes provided a false name and date of birth while she was lawfully detained and a criminal investigation was being conducted.

At approximately 0248 hours of the same date, Mr. Maglio was transported from the CVS store, to the intersection of Hardee Rd and Riviera Dr and a show-up was conducted. Mr. Maglio positively identified all three females and the subject vehicle.

Miranda warnings was read to all three Offenders (per card) and all three invoked their right to remain silent.

Ms. Del Val was placed under arrest for petit theft. Ms. Fuentes was placed under arrest for petit theft and for providing a false name while lawfully detained.

A search incident to arrest revealed two bottles of Korbel Brut on the floor boards of the rear compartment of the vehicle, where Ms. Fuentes was sitting at the time of the traffic stop. One bottle was behind the driver seat and the second one behind the front passenger seat, by Ms. Fuentes' feet. The search also revealed an open alcohol container (a bottle of Jamison whiskey) in the rear compartment of the vehicle, behind the driver's seat. When the two Korbel bottles were found in the rear compartment of the vehicle, Ms. Alen spontaneously stated that the bottles were not her property and she did not know how they ended up in backseat of her vehicle. She also spontaneously stated that the Korbel bottles must belong to either Ms. Fuentes or Ms. Del Val.

Ms. Alen was cited for having an open container inside the vehicle while driving (Citation ADE9JFE) and for having her registration expired more than 6 months (ADE9JEE).

Officer Wentzell (ID# 7661) transported the two bottles of Korbel to CVS in an attempt to identify if the bottles were property of the CVS store. Mr. Maglio scanned the SKU codes and was able to very that the Korbel bottles were part of the store's inventory. Officer Wentzell released the 2 bottles of Korbel to Mr. Maglio.

Further investigation and review of the store's video surveillance footage revealed that Ms. Del Val and Ms. Fuentes entered the CVS approximately three and a half hours prior to this incident. Ms. Del Val and Ms. Fuentes are captured on video surveillance footage entering the store at 2307 hours on 3/9/2021 and exiting at 2310 hours. CGPD officers and Mr. Maglio were unable to determine if anything was stolen at that time. Ms. Fuentes was wearing a different color and style of shirt when she entered the store at 2307 hours on 3/9/2021. At the time of my interaction with Ms. Fuentes, she was wearing a green colored shirt over the black shirt she wore during her first visit to the store.

Crime Scene Certified Officer Gibson (ID# 11014) responded and photographed the scene.

Mr. Maglio issued a trespass warning to all three Offenders.

Ms. Alen was made whole and released. She removed the Chevrolet Sparks from the scene.

Ms. Del Val and Ms. Fuentes were transported to TGK via CGPD processing.

Sgt. Koppel (ID# 8114) and Sgt. St. Amand (ID# 8432) were on scene and are fully apprised on all details regarding this incident.
