**RESOLUTION**

**A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE ELECTRICAL CONTROL PANEL PURCHASE PROJECT TO CUSTOM CONTROLS TECHNOLOGY INC. THE RESPONSIVE AND RESPONSIBLE BIDDER, IN THE AMOUNT OF \$688,723.35, PURSUANT TO SECTION 2-763 OF THE PROCUREMENT CODE ENTITLED “CONTRACT AWARD”.**

**WHEREAS**, on December 2, 2020, the Procurement Division of Finance formally advertised, issued, and distributed IFB 2020-043 for Electrical Control Panel Purchase (“The IFB”); and

**WHEREAS**, a total of six (6) prospective providers downloaded the IFB package from PublicPurchase, the City’s web-based e-Procurement service; and

**WHEREAS**, on December 29, 2020, one (1) response was received and evaluated by the Procurement Division and deemed responsive per the requirements of the IFB; and

**WHEREAS**, the Public Works Department concurs with the Chief Procurement Officer’s recommendation to award the Electrical Control Panel Purchase to Custom Controls Technology, Inc; and

**WHEREAS**, Section 2-585 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts.

**NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**Section 1.** The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**Section 2.** That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager award the Electrical Control Panel Purchase contract to Custom Controls Technology Inc., the responsive and responsible bidder in the amount of \$655,927.00 pursuant to Section 2-763 of the Procurement Code entitled “ Contract Award” and Invitation for Bids (IFB) 2020-043 as well as an additional \$32,796.35 for 5% contingency allowance to address any unforeseen conditions with the project.

**Section 3.** That this Resolution shall become effective upon the date of its adoption herein.
