## **RESOLUTION NO. 2023-356**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER TO REQUEST ADDITIONAL SPENDING AUTHORITY IN THE AMOUNT OF \$150,000 FOR A CONTRACT AWARDED TO JOHN BELL CONSTRUCTION, INC., PURSUANT TO SECTION 2-764 OF THE CITY'S PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS".

**WHEREAS**, the Granada Diner space located in the Pro Shop is in need of remodeling to accommodate any future dining operation; and

**WHEREAS,** on January 1, 2023, the Commission approved a special procurement/bid waiver via Resolution No. 2023-10 to authorize the selection of a qualified contractor to perform the work; and

**WHEREAS,** it has been determined that additional work outside of the scope of work initially negotiated is necessary; and

**WHEREAS,** it is necessary to seek additional spending authority to address any future needs required to complete the project;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission accept a recommendation of the City Manager for additional spending authority for the renovation of the Granada Diner in an estimated amount of \$150,000 or in an amount not to exceed the available budget as well as authorize any future construction change orders pursuant to Section 2-764 of the City's Procurement Code.
- **SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
