RESOLUTION NO. 2020-146

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION TO AUTHORIZE THE PURCHASE OF EQUIPMENT FOR THE FIRE DEPARTMENT FROM GAUMARD SCIENTIFIC COMPANY, INC. AS A "SOLE SOURCE PROCUREMENT," PURSUANT TO SECTION 2-689 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the Fire Department is interested in purchasing a new medical training patient simulator; and

WHEREAS, the Trauma HAL Trauma and Emergency Patient Simulator is designed to train Fire Department Paramedics; and

WHEREAS, the cost for the purchase of this equipment totals \$28,475; and

WHEREAS, Gaumard Scientific Company, Inc is the exclusive supplier of this equipment; and

WHEREAS, Section 2-689 of the Procurement Code entitled "Sole Source Procurement" authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City commission accepts the recommendation and authorizes the City Manager to waive the competitive bid process of the Procurement Code and purchase equipment from Gaumard Scientific Company, Inc. in the amount of \$28,475, pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


