A RESOLUTION OF THE CITY COMMISSION AMENDING MAYOR LAGO'S STRATEGIC PRIORITIES PLAN TO INCLUDE PRIORITY #9 - TRAILBLAZING WITH TECHNOLOGY.

- **WHEREAS**, following his election in April of 2021 Mayor Vince Lago began finalizing a strategic priorities plan for his term as Mayor; and
- WHEREAS, the Mayor assembled these priorities in order to govern with integrity and transparency and outline his priorities as mayor; and
- WHEREAS, the Mayor's Strategic Plan Priorities include increasing transparency in City governance, improving accountability, engaging residents through outreach, enhancing quality of life for residents, encouraging a thriving business community, serving as strong stewards for the environments and maintaining the City's historic integrity; and
- **WHEREAS**, the City Commission reviewed and provided input on the Mayor's Strategic Priorities Plan and adopted the plan by way of Resolution No. 2021-121 passed during a City Commission meeting held on June 8, 2021; and
- **WHEREAS**, during a special workshop, held on March 14, 2022, the Mayor's Council discussed and approved the suggested language that would be used to amend the Mayor's Strategic Plan in favor of adding a ninth priority: "Priority #9 Trailblazing with Technology;
