A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, DIRECTING THAT CITY STAFF AMEND THE PROPOSED ANNUAL BUDGET OF ESTIMATED REVENUES AND **EXPENDITURES FOR THE FISCAL YEAR BEGINNING** OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024 PRIOR TO THE SECOND READING OF THE ORDINANCE ADOPTING SAID BUDGET IN ORDER TO REALLOCATE FUNDS IN THE CAPITAL BUDGET FROM PHILLIPS PROJECTS PARK TOWARDS THE CITY HALL COMPLEX WINDOWS

WHEREAS, on September 13, 2023 the City Commission considered, and adopted on first reading an ordinance adopting the annual budget of estimated revenues and expenditures for the 2023-2024 Fiscal Year; and

WHEREAS, that proposed budget includes \$4,000,000 of new funding, \$3,800,000 in new funding from the General Capital Improvement funds and \$200,000 from the Florida Recreation Development Assistance Program Grant for Phillips Park capital project; and

WHEREAS, the City currently has \$3,135,196 of available prior year funding for the renovations to Phillips Park; and

WHEREAS, the City Commission has identified an immediate need to address the windows in the City Hall Complex; and

WHEREAS, the City Commission wishes to amend the five-year capital improvement plan so that any funding diverted from Phillips Park to the City Hall Complex capital project will be replaced and refunded in the 2024-2025 Fiscal Year budget, subject to availability of funds; and

WHEREAS, the City Commission directs City staff to amend the proposed budget prior to second reading to re-allocate \$2,500,000 from the \$3,800,000 proposed new funding from the General Capital Improvement funds for Phillips Park to the City Hall Complex capital project to go towards the City Hall Complex windows.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission directs City staff to amend the proposed budget ordinance prior to second reading to re-allocate \$2,500,000 from the \$3,800,000 proposed new funding from the General Capital Improvement funds for the for Phillips Park capital project to go towards the City Hall Complex windows.

SECTION 3. That the City's five-year capital improvement plan be amended so that the \$2,500,000 diverted and reallocated from Philips Park will be replaced and refunded in the 2024-2025 Fiscal Year budget, subject to availability of funds.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
