ITEM TITLE:

Resolution. A Resolution of the City Commission authorizing entering into a Lease renewal with Plumer Management, LLC, for eleven (11) parking spaces on City property behind 5915 Ponce De Leon Boulevard, Coral Gables, FL, for a period of three (3) years (June 1, 2021-May 31, 2024).

DEPARTMENT HEAD RECOMMENDATION:

BRIEF HISTORY:

Resolution No. 30051 passed and adopted on February 27, 2001, authorized a three (3) year lease for twelve (12) parking spaces on City property to Plumer Management, LLC ("Tenant"), 5915 Ponce de Leon Boulevard at a rate of \$30.00 per month. The City and Tenant entered into a Lease Agreement dated August 8, 2001.

Resolution No. 2007-92 passed and adopted May 22, 2007, authorized a renewal of the lease for an additional year a rate of \$60.00 per space, and the parties entered into a Lease Agreement dated June 1, 2007.

Resolution No. 2009-179 passed and adopted on July 7, 2009, authorized the extension of the term for an additional one-year period at a rate of \$60.00 per space, and the parties signed a letter agreement to that effect.

Resolution No. 2010-98 passed and adopted on May 26, 2010, authorized a renewal of an additional three (3) years with a one (1) year option to renew at a rental rate of \$85.00 per space, and the parties entered into a Lease Agreement to that effect.

Public Work's surveyor reviewed the site and determined the parking spaces needed to be reduced from twelve (12) to eleven (11) to allow proper access to alley by service and emergency vehicles.

Resolution No. 2018-143 passed and adopted on May 22, 2018, authorized a renewal of an additional three (3) years with a one (1) year option to renew at a rental rate of \$90.00 per space and the lease expires May 31, 2021.

Tenant is interested in renewing the lease for a period of three (3) years from June 1, 2021 to May 31, 2024, for the eleven (11) spaces. Rent shall increase to \$110.00 per space which may be increased from time to time to the standard rate the City charges for those spaces available for individual permit within the general area of the Tenant's spaces, provided that the rate may not increase more than five percent (5%) annually.
