RESOLUTION NO. 2026-131

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE POLICE DEPARTMENT TO AUTHORIZE THE PURCHASE OF ENHANCEMENTS FROM MARK43 AS A “SOLE SOURCE PROCUREMENT”, IN AN ESTIMATED AMOUNT OF \$265,000.00 PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the Innovation and Technology, Fire and Police Department have determined the need to purchase enhancements to our existing Mark43 platform; and

WHEREAS, these specific enhancements include Network Security, CAD, RMS and Analytics Software, products of VMark43; and

WHEREAS, Mark43 is the sole vendor that is capable of providing these enhancements to their proprietary software; and

WHEREAS, the cost for the purchase of these enhancements is an estimated amount of \$265,000.00 for a 5 ½ year term; and

WHEREAS, Section 2-689 of the Procurement Code, entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the city; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation and authorizes the City Manager to authorize the Police Department to purchase these enhancements for an estimated amount of \$265,000.00 for a term of 5 ½ years pursuant to Section 2-689 of the City’s Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

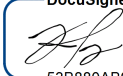

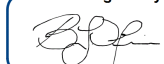

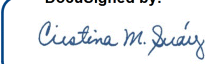
