A RESOLUTION ACCEPTING THE BID OF BAY PLUMBING CO., AS BEING THE LOWEST AND MOST RESPONSIVE, RESPONSIBLE BID IN THE AMOUNT OF \$39,440.00, FOR THE DOMESTIC WATER PUMP PROJECT AT THE CORAL GABLES POLICE HEADQUARTERS, PROJECT PWD #A-08-012.

**WHEREAS**, the following bids from the City's pre-qualified plumbing contractors were opened on October 20, 2008, for the domestic water pump project at the Coral Gables Police Headquarters, located at 2801 Salzedo Street, Coral Gables, Florida, PWD #A-08-012:

**WHEREAS**, the bid of Bay Plumbing Co. for the domestic water pump project at the Coral Gables Police Headquarters, in the amount of \$39,440.00, as being the lowest and most responsive, responsible bid opened on October 20, 2008;

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to accept the bid of Bay Plumbing Co., for the domestic water pump project at the Coral Gables Police Headquarters, in the sum of \$39,440.00.

**SECTION 3.** That said bid has been recommend by the Public Works Department as being the lowest responsive, responsible bid from among the aforementioned bids opened on October 20, 2008.

**SECTION 4.** That the City Commission does hereby instruct the City Manager to direct the Finance Director to allocate the necessary funds and to charge this project to the Capital Improvement Fund.

**SECTION 5.** That this resolution shall become effective upon the date of its passage and adoption herein.
