Α RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AWARD THE AUTOMOTIVE BODY REPAIRS (COLLISION DAMAGE) TO FARACO TIP TOP PAINT & BODY SHOP AS THE PRIMARY RESPONSIVE AND RESPONSIBLE BIDDER AND CHINO'S INK WERKS, INC. AS THE SECONDARY RESPONSIVE AND RESPONSIBLE BIDDER IN AN ESTIMATED AMOUNT OF \$50,000.00 ANNUALLY FOR A PERIOD OF THREE (3) YEARS WITH TWO (2) ONE (1) YEAR OPTIONS TO RENEW, PURSUANT TO INVITATION FOR BIDS (IFB) 2019-040 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD"

WHEREAS, on August 26, 2019, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Automotive Body Repairs (collision damage); and

WHEREAS, eight (8) prospective bidders downloaded the IFB package from Public Purchase, the City's web-based e-Procurement service; and

WHEREAS, on September 23, 2019, two (2) bids were received in response to the IFB 2019-033 from: Faraco Tip Top Paint & Body Shop; and Chino's Ink Werks, Inc., and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award the Automotive Body Repairs (collision damage) contract to Faraco Tip Top Paint & Body Shop as the primary responsive and responsible bidder and Chino's Ink Werks, Inc. as the secondary responsive and responsible bidder, and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as

being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Procurement Officer to award the Automotive Body Repairs (collision damage) contract to Faraco Tip Top Paint & Body Shop as the primary responsive and responsible bidder and Chino's Ink Werks, Inc. as the secondary responsive and responsible bidder to provide the services in an estimated amount of \$50,000.00 annually, not to exceed the available budget, for a period of three (3) years with two (2) one (1) year options to renew, pursuant to Invitation for Bids (IFB) 2019-040 and Section 2-763 of the Procurement Code entitled "Contract Award".

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
