RESOLUTION NO. 2014-

RESOLUTION AUTHORIZING EXPENDITURES IN THE AMOUNT OF \$136,895.21 FROM FEDERAL FORFEITED ASSET FUND (F.A.F.) MONIES FOR THE ACQUISITION OF ADDITIONAL LAW ENFORCEMENT EQUIPMENT; THE SPECIALIZED VEHICLE EQUIPMENT FOR UTILIZATION BY THE CORAL GABLES POLICE DEPARTMENT.

WHEREAS, the Coral Gables Police Department participates with federal law enforcement agencies of the United States Departments of Justice, Treasury and/or Homeland Security in joint law enforcement operations, and the Coral Gables Police Department's participation in those joint investigations produces federally seized funds, and

WHEREAS, at the discretion of the United States Attorney General under United States Statute 18 U.S.C. Section 981(e)(2) and 21 U.S.C. Section 881(e)(1)(a) and (e)(3)(b), the Coral Gables Police Department may lawfully retain at the conclusion of the legal proceedings the federally seized funds, and

WHEREAS, the Coral Gables Chief of Police, Dennis L. Weiner, and the Coral Gables Finance Director, Diana Gomez, attest to have deposited the sum of \$136,895.21 in said forfeited funds into the Coral Gables Forfeited Asset Fund, and

WHEREAS, the Coral Gables Chief of Police requests to expend these funds for use by the Department to acquire additional law enforcement equipment, and

WHEREAS, the Coral Gables Chief of Police certifies that the request complies with all provisions of the appropriate F.A.F. statutory requirements as identified in the United States Justice Department's publication entitled "*Guide to Equitable Sharing for State and Local Law Enforcement Agencies*", and

WHEREAS, the F.A.F. Committee met on August 5, 2014, and followed the F.A.F. Committee operating procedures adopted on July 23, 2002, and

WHEREAS, the F.A.F. Committee approved the Coral Gables Chief of Police's request to expend the available forfeited asset funds on the specific items listed below on this resolution;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

1. That the City Manager is hereby directed to authorize the Finance Director to expend \$136,895.21 to the Coral Gables Police Department from Federal Forfeited Asset

Fund monies to provide for the acquisition of additional law enforcement equipment; the specialized vehicle equipment for utilization by the Coral Gables Police Department.

2. That this Resolution shall become effective upon the date of its adoption herein.
