are in violation of the following sections and subject to Section 101-107 of the City Code of the City of Coral Gables by:

City Code - Chapter 105. Minimum Housing.

Roof, walls, driveway and sidewalks are dirty. Walls are discolored with different paint colors.
Driveway ribbons are cracked and in disrepair. Fence at rear of property and gate and fence on west side is in disrepair.

The following steps should be taken to correct the violation:

Remedy: Must pressure wash walls, walkways, roof. Must paint walls. Must repair fence. Must repair driveway ribbons.
Must obtain all permits and approvals necessary to complete work.

Please be advised that if someone will be attending the hearing on your behalf, he or she must provide a power of attorney from you at the time of the hearing.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- **You may be subject to substantial fines that may not be mitigated.**
- **You may also be required to repair or restore the historic structure.**
- **If the historic structure is allowed to deteriorate to the point where it must be demolished:**
 - **the City Code requires that you replace the structure with a similar historically-appropriate structure; and**

- o **the property will no longer qualify for an historic preservation tax exemption.**
