RESOLUTION NO. 2022-250

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CONTRACT MODIFICATION TO THE ELEVATOR, ESCALATORS AND MOVING WALKS WITH RELATED EQUIPMENT SERVICES, ACCESSORIES AND SUPPLIES CONTRACT 100516-TKE, WITH THYSSENKRUPP ELEVATOR CORPORATION PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, IN AN ANNUAL ESTIMATED AMOUNT OF \$145,000 FOR ADDITIONAL ELEVATOR REPAIR SERVICES TO BE PERFORMED.

WHEREAS, the City entered into a piggyback agreement pursuant to Procurement Code 2-945 with ThyssenKrupp Elevator Corporation to provide elevator repair services on May 24, 2018; and

WHEREAS, this service contract provides troubleshooting and correcting problems in the elevator systems, pre-maintenance, maintenance repair, emergency repair, and other elevator related work; and

WHEREAS, based on additional City facilities and ongoing repairs and maintenance, it has become necessary to increase the spending authority on the contract to address on-going needs; and

WHEREAS, additional facilities include Fire Station No. 2/Trolley and Public Safety Building and other city facilities that are coming online in the future;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

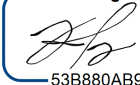

That the City Commission approves the contract modification in the amount of \$145,000 during fiscal year 2022-2023 and for the duration of the contract, not to exceed the available budget for additional work performed under the contract, pursuant to Section 2-764(b) of the City’s Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

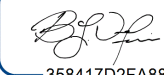

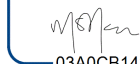
