AMENDMENT # 3

THIS **THIRD AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT** is made as of this ²³ day of January, 20²⁶, between the City of Coral Gables (hereinafter called the "City"), and Phillips Heavy, Inc. (hereinafter called the "Professional").

RECITALS

WHEREAS, the City and Professional previously entered into a Professional Services Agreement effective August 21, 2018, ("Agreement"), for Disaster Debris Removal Services RFP 2018-009B ("Services"); and

WHEREAS, the City approved an extension through November 30, 2025, pursuant to Resolution 2025-98, adopted on May 20, 2025: and

WHEREAS, the Parties desire to extend the Agreement from December 1, 2025, on a month-to-month basis, until May 31, 2026; and

WHEREAS, the City approved the extension through May 31, 2026, pursuant to Resolution 2025-436, adopted on November 18, 2025: and

WHEREAS, per Section 16.1 Modification, the agreement may not be amended or modified unless in writing and signed by both parties.

NOW, THEREFORE, the Parties agree, understand, accept, and acknowledge that through this Amendment, the Professional Services Agreement for Disaster Debris Removal Services is hereby modified as follows:

1. The City and Professional hereby acknowledge that the extension period shall commence December 1, 2025, on a month-to-month basis, and continue until May 31, 2026.
2. All other terms and conditions of the agreement remain unchanged and in effect.

All other terms and provisions of the Agreement are hereby confirmed and shall remain in full force and effect, except as modified herein.




