**RESOLUTION NO. 2025-04**

A RESOLUTION OF THE CITY COMMISSION CONFIRMING THE NOMINATION OF SUREYA SERRET, WHO RAN UNOPPOSED TO THE CITY OF CORAL GABLES RETIREMENT BOARD, PARTICIPATING REGULAR FULL-TIME (GENERAL/TEAMSTER) EMPLOYEE REPRESENTATIVE SEAT FOR A TWO (2) YEAR TERM BEGINNING JANUARY 1, 2025 THROUGH DECEMBER 31, 2026.

**WHEREAS**, on Monday November 4, 2024 a Nominating Petition form was emailed to each department/division within the City of Coral Gables to nominate a candidate for the Participating Regular Full-time (General/Teamster) Employee Representative seat which resulted in nominations being received by the end of the filing deadline of Friday, November 15, 2024 at 5 p.m.; and

**WHEREAS**, on Thursday, November 21, 2024, another Nominating Petition form was emailed to each department/division within the City of Coral Gables to nominate a candidate for the Participating Regular Full-time (General/Teamster) Employee Representative seat with a submittal deadline of Friday, December 6, 2024 at 5:00 p.m. At the close of the Nominating Petition submittal deadline only one candidate's name was proffered, Sureya Serret who ran unopposed, thereby declaring her the winner; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:**

**SECTION 1.** The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon passage and adoption hereof.

**SECTION 2.** That the City Commission does hereby confirm the nomination of Sureya Serret as the Participating Regular Full Time (General/Teamster) Employee Representative, to serve the remainder of the unexpired two-year term which began on January 1, 2025 through December 31, 2026.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
