

**EXTENSION OF THE CONTRACT BETWEEN THE PARTIES TO PROVIDE  
TRAFFIC ENGINEERING CONSULTING SERVICES**

This EXTENTION OF CONTRACT TO PROVIDE TRAFFIC ENGINEERING CONSULTING SERVICES ("extension") is made and entered as of the \_\_\_\_ day of \_\_\_\_\_, 2016, by and between The City of Coral Gables ("City") and DAVID PLUMMER AND ASSOCIATES, INC. ("Consultant").

**RECITALS**

**WHEREAS**, the City and Consultant have previously entered into a certain contract dated February 17, 2012 ("contract") whereby the Consultant provides traffic engineering consulting services; and

**WHEREAS**, the contract expires on February 17, 2016, and the parties desire to extend the contract through June 17, 2016, ("the extension period") to provide time for a revised scope of services, a Request for Qualifications (RFQ) process to be completed, a new contract to be approved, and to authorize an extension of the existing contract; and

**WHEREAS**, the Consultant has agreed to continue to provide traffic engineering consulting services through an extension of the aforementioned contract for an additional period through June 17, 2016, under the same terms and conditions of the contract.

**NOW, THEREFORE**, in consideration of the promises and the mutual covenants contained herein, the City agrees to retain the Consultant during the extension period.

1. **INCORPORATION OF RECITALS.** The foregoing recitals are true and correct and are incorporated herein. All terms used herein shall have the meaning ascribed to such terms in the contract, unless defined otherwise herein.

2. **TERM.** The parties hereby acknowledge that the extension period shall be February 17, 2016 through June 17, 2016, unless terminated earlier pursuant to the terms of the contract. Thereafter, the term will be automatically renewed at three (3) month intervals at the City's option.

All other terms and provisions of the contract are hereby confirmed and shall remain in full force and effect, except as modified herein.
