RESOLUTION NO. 2008-64

A RESOLUTION FINDING THE UNIVERSITY OF MIAMI CAMPUS ART MASTER PLAN SUFFICIENT IN MEETING THE REQUIREMENTS OF THE ART IN PUBLIC PLACES ORDINANCE AS REQUIRED UNDER THE EXEMPTION CRITERIA WHICH PROVIDES THAT AN ACCREDITED COLLEGE AND/OR UNIVERSITY THAT MAINTAINS AT ITS CAMPUS A PUBLICLY ACCESSIBLE PERMANENT COLLECTION OF ART OF AT LEAST THIRTY (30) SCULPTURES, AND/OR OTHER PUBLIC ART IN ACCORDANCE WITH A CAMPUS ART MASTER PLAN.

WHEREAS, the City Commission of Coral Gables, on December 12, 2007, approved the development of an Art in Public Places program to assist in the maintenance of the historic public art through Municipal Construction Project funding and the acquisition, installation, and maintenance of new, equally significant public art for the enjoyment of citizens and visitors through the non-Municipal construction contributions; and

WHEREAS, the City Commission of Coral Gables has provided for limited exceptions to the requirements of the Art in Public Places program; and

WHEREAS, one exemption is for an accredited college and/or university that maintains at its campus a publicly accessible permanent collection of art of at least thirty (30) sculptures and/or other public art in accordance with a Campus Art Master Plan; and

WHEREAS, the aforementioned exemption requires the college and/or university to provide a Campus Art Master Plan describing the selection criteria, placement, and maintenance of the permanent collection and future sculptures and other public art, and describing plans for the evolution and growth of such public art collection over time to be submitted for review by the City Commission to confirm the sufficiency of the Campus Art Master Plan; and

WHEREAS, at the City Commission meeting of April 29, 2008, the University of Miami made a personal appearance presenting its Campus Art Master Plan which described the selection criteria, placement, and maintenance of the campus' collection;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption here

SECTION 2. That the City Commission has reviewed the University of Miami's Campus Art Master Plan, and found that it was sufficient in meeting the criteria and placement of artwork, as required by the Art in Public Places Ordinance.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
