**RESOLUTION NO. 2023-127**

A RESOLUTION OF THE CITY COMMISSION DIRECTING CITY STAFF TO EXPLORE THE FEASIBILITY OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF CORAL GABLES AND THE MIAMI-DADE COUNTY SCHOOL BOARD REGARDING CORAL GABLES SENIOR HIGH SCHOOL AND EXPLORE FUNDING OPTIONS FOR A STUDY REGARDING THE USE OF CORAL GABLES SENIOR HIGH SCHOOL'S ATHLETIC FIELDS AND FACILITIES

**WHEREAS**, Coral Gables has made it a mission to find opportunities to increase the number of parks in the city; and

**WHEREAS**, there is very little park space in the area surrounding Coral Gables Senior High School; and

**WHEREAS**, Coral Gables is a growing city with many young families that would benefit from an increase in the number of city parks; and

**WHEREAS**, the city is interested in pursuing opportunities to cooperate with other local government agencies and community groups to improve and further beautify the city; and

**WHEREAS**, beautifying the Coral Gables Senior High School campus will contribute to the school's excellent reputation and benefit the students and the local Coral Gables community;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That the City Commission directs City Staff to seek out potential funding sources to renovate the Coral Gables Senior High School athletic fields, fencing, and landscaping with the goal of creating a new city park.

**SECTION 3.** That the City Commission directs the City Attorney to explore the feasibility of an interlocal agreement between the City of Coral Gables and the Miami-Dade County School Board for the creation of a city park at Coral Gables Senior High School.

**SECTION 4.** That this Resolution shall become effective upon the date of its passage and adoption herein.
