

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2016-10**

A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES, FLORIDA IN SUPPORT OF OBTAINING AN ESTIMATE FOR THE PERFORMANCE OF AN INTER-DECENNIAL CENSUS FOR THE PURPOSE OF QUALIFYING FOR A SEAT, FOR THE CITY OF CORAL GABLES, ON THE METROPOLITAN PLANNING ORGANIZATION (MPO).

**WHEREAS**, the MPO guides the transportation planning process in Miami-Dade County; and

**WHEREAS**, the MPO was created as required under Sec. 163.01, F.S.; and

**WHEREAS**, the MPO ensures conformance with federal regulations requiring that highways, mass transit and other transportation facilities and services are properly developed and deployed in relation to the overall plan of urban development and to approve plans for regional and state transportation network accessibility; and

**WHEREAS**, the City of Coral Gables is located in the middle of Miami-Dade County causing commuters to travels through the City on a daily basis thereby making the issues of transportation and urban development of paramount importance to the City; and

**WHEREAS**, the MPO includes a representative from each municipality in Miami-Dade County with a population over 50,000; and

**WHEREAS**, the City Commission believes that the City of Coral Gables currently has a population of over 50,000; and

**WHEREAS**, in order to confirm the population of the City of Coral Gables, a inter-decennial census must be conducted; and

**WHEREAS**, there is a cost associated with the performance of an inter-decennial census;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby support the obtaining of an estimate to conduct an inter-decennial census for the purpose of confirming that the current population of the City of Coral Gables exceeds 50,000, thereby qualifying the City of Coral Gables for a seat on the MPO.

**SECTION 3.** That said Resolution shall become effective upon the date of its passage and adoption herein.


