Mrs Perez,

When we spoke about the mirrors, I explained that you would need the approval from one the building official's to have them. You said you would speak with Manny Lopez or Suramy Cabrera. The city typically doesn't allow the mirrors in residential areas.

I had another case that I cited at the same time as yours, that installed mirrors, and at Code Board they we're required to remove mirrors and cut their hedge.

If you come into compliance before the scheduled code board meeting, we can cancel your requirement to appear and close out the case.
