**ITEM TITLE:**

**ACTION REQUESTED BY THE COMMISSION:**

That the City Commission approves the nomination submitted by Vice Mayor Kerdyk, whereby Doug Austin was nominated to serve as a member of the School and Community Relations Committee, for a two year term beginning June 1, 2007 through May 31, 2009, effective as of October 14, 2008.

**RECOMMENDATION OF THE CITY CLERK:**

That the aforementioned individual be confirmed by the City Commission to serve as members of the School and Community Relations Committee.


**BACKGROUND:**

**MEMBERSHIP:** Nine (9) members (Resolution No. 2005-124), five (5) to be appointed by the Members of the Commission, one (1) to be appointed by the City Manager, one (1) to be appointed by Crime Watch, one (1) to be appointed by Coral Gables High School, one (1) to be appointed by Ponce Middle School, and one (1) to be appointed Crime Watch.

**QUALIFICATIONS:** That the (6) members appointed by the City Commission and City Manager should include three (3) members who reside or work in the vicinity of Coral Gables High School and three (3) members who reside or work in the vicinity of Ponce de Leon Middle school.

**FUNCTION:** Committee shall be to provide an opportunity for dialogue between Coral Gables High, Ponce Middle School and its neighbors in the City of Coral Gables; to create a forum to address complaints and concerns of neighbors in the vicinity of the schools, to establish a procedure to resolve neighborhood problems; to preserve the harmony of the neighborhood and the school; and to establish a line of communication to address issues of quality of education offered to students attending schools within the City of Coral Gables.
