**RESOLUTION NO. 2024-97**

A RESOLUTION OF THE CITY COMMISSION AMENDING RESOLUTION NO. 2019-359 TO EXPAND THE RESIDENT RATE DISCOUNTS OFFERED TO CORAL GABLES TEACHERS WHO PURCHASE AN ANNUAL MEMBERSHIP AT THE WAR MEMORIAL YOUTH CENTER OR VENETIAN POOL.

**WHEREAS**, the City Commission and the City's School Community Relations Committee seek to honor and recognize teachers who serve the Coral Gables community through a variety of initiatives; and

**WHEREAS**, in 2019, the City Commission adopted Resolution No. 2019-359, which allowed teachers that teach within the City of Coral Gables to purchase resident rate membership packages at the Coral Gables War Memorial Youth Center and/or the Venetian Pool; and

**WHEREAS**, the City Commission wishes to expand the program in an effort to recognize more teachers who serve the Coral Gables community;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission hereby authorizes the City Manager and the Community Recreation Department to provide Coral Gables teachers with resident rate discounts for annual membership at the War Memorial Youth Center and Venetian Pool.

**SECTION 3.** That for the purpose of this Resolution, Coral Gables teachers are defined as those teachers employed at a public or private elementary, middle or high school within the municipal boundaries of the City of Coral Gables or at one of the schools under the purview of the School Community Relations Committee, which as of today include, Coral Gables Preparatory Academy, Sunset Elementary School, George Washington Carver Elementary School, David Fairchild Elementary School, Frances Tucker Elementary, Henry S. West Laboratory School, Ponce de Leon Middle School, George Washington Carver Middle School, International Studies Preparatory Academy, Somerset Academy, and Coral Gables Senior High School.


**SECTION 4.** That the Community Recreation Department shall adopt a verification procedure to confirm the identity and employment status of individuals seeking to utilize this benefit.


