RESOLUTION NO. 2016-43

A RESOLUTION OF THE CITY OF CORAL GABLES, FLORIDA AMENDING AND SUPPLEMENTING RESOLUTION NO. 2015-226 TO AMEND THE SERIES DESIGNATION OF THE BONDS; PROVIDING CERTAIN OTHER MATTERS IN CONNECTION WITH THE MAKING OF SUCH LOANS. (*THIS RESOLUTION CHANGES THE TITLE OF THE LOAN FROM "SERIES 2015" TO "SERIES 2016" FOR THE STREETScape PROJECT TAXABLE LOAN*).

WHEREAS, the City of Coral Gables, Florida, a municipal corporation organized and existing under the laws of the State of Florida (the "Borrower"), previously adopted Resolution No. 2015-226 on September 22, 2015 (the "Approving Resolution"), authorizing and approving the Loan (as defined below);

WHEREAS, the Borrower now desires to amend the Approving Resolution by amending the series designation of the Loan;

WHEREAS, the Sunshine State Governmental Financing Commission will issue its Sunshine State Governmental Financing Commission Taxable Capital Improvement Revenue Bonds, Series 2016C (the "Series 2016C Bond") and loan the proceed thereof to the Borrower (the "Loan") and enter into a loan agreement with the Borrower;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1: That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The Authorizing Resolution is hereby amended by deleting all references to Series 2015 and replacing it with Series 2016.

SECTION 3. Except as specifically amended hereby, the Authorizing Resolution shall remain in full force and effect as in existence on the date hereof and is hereby ratified and confirmed in all respects.

SECTION 4. All prior resolutions of the Borrower inconsistent with the provisions of this Resolution are hereby modified, supplemented and amended to conform with the provisions herein contained and, except as otherwise modified, supplemented and amended hereby, shall remain in full force and effect.

SECTION 5. This Resolution shall become effective upon the date of its passage and adoption herein.
