

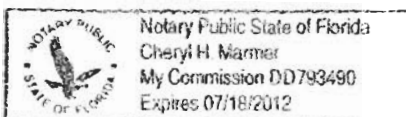

### BOARD OF ADJUSTMENT NOTICE OF PUBLIC HEARING

All interested parties are hereby notified that the Board of Adjustment of the City of Coral Gables, Florida, will hold a public hearing for the purpose of hearing variance requests and taking action on such requests, reviewing and taking action on appeals from Administrative Officials, and other decision making orders, as outlined in Section 2-401 of Ordinance No. 2007-01, as amended and known as the "Zoning Code" of the City of Coral Gables, Florida, to wit:

1. Case No. BA-09-12-3153 Consider a variance request in regard to the maximum height for the perimeter fence wall for the existing residence located at 533 Sunset Road, Coral Gables, Florida.
2. Case No. BA-10-01-3908 Consider a variance request in regard to the proposed signs on awnings for the tenant "Chase" in the existing commercial building located at 1300 Ponce De Leon Blvd., Coral Gables, Florida.

Interested parties may express their views at the hearing or file them in writing with the undersigned on or before the commencement of the hearing which will be held before the Board of Adjustment of the City of Coral Gables at City Hall, 405 Biltmore Way, in the Commission Chamber, Coral Gables, Florida, commencing at 8:00 A.M., Monday, April 5, 2010.
