**RESOLUTION NO. 2011-29**

RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE BILTMORE GOLF COURSE REMEDIATION PROJECT TO CHEROKEE ENTERPRISES, INC. IN THE AMOUNT OF \$86,633.03 PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD" AND REQUEST FOR PROPOSALS (RFP) 2010.11.01.

**WHEREAS**, on November 5, 2010, the Procurement Division of Finance formally advertised the Biltmore Golf Course Remediation Project Request for Proposals (RFP) 2010.11.01; and

**WHEREAS**, on November 16, and 19, 2010, two (2) non mandatory pre-bid conferences were held with twenty-two (22) prospective bidders in attendance out of the eighty-six (86) contractors and subcontractors who either downloaded the bid document from the Procurement webpage or picked up the bid documents from the Procurement Division of Finance; and

**WHEREAS**, on December 9, 2010, eight (8) proposals were submitted: GEO Tech Environmental, Belair Builders/Progressive, HAS Engineers & Scientists, American Compliance Tech (ACT), Eagle SWS, WRS Infrastructure & Environmental, MCO Environmental and Cherokee Enterprises, Inc.; however, three (3) proposals (GEO Tech Environmental, Eagle SWS, and WRS Infrastructure & Environmental) were disqualified for being non-responsive; and

**WHEREAS**, on January 12, 2011, the Evaluation Committee conducted their evaluation of the proposals with the pricing component of each proposal evaluated separately based on the low price reward method; and

**WHEREAS**, based on the composite score of the Evaluation Committee and the pricing evaluation, Cherokee Enterprises, Inc., was determined to be the most responsive and responsible proposer, with their proposal of \$86,633.03; and

**WHEREAS**, Section 2-650 of the Procurement Code entitled "Authority" authorizes to the Chief Procurement Officer to determine the lowest or highest responsive and responsible bidder and make recommendations;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby authorize the City Manager to accept the recommendation of the Chief Procurement Officer to award the Biltmore Golf Course Remediation Project to Cherokee Enterprises, Inc. in the amount of \$86,633.03 pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Request for Proposals (RFP) 2010.11.0.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.


