## **RESOLUTION 2024-**

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE REALLOCATION OF FUNDS IN THE 2024-2028 FIVE YEAR CAPITAL IMPROVEMENT PLAN TO CREATE A CONCEPTUAL DESIGN FOR POTENTIAL IMPROVEMENTS, INCLUDING OUTDOOR COMMUNITY RECREATION SPACES, TO THE CORAL GABLES SENIOR HIGH SCHOOL ATHLETIC COMPLEX.

**WHEREAS,** the City Commission would like to budget up to \$50,000 in order to move forward with conceptual designs for potential improvements, including outdoor community recreation spaces, to the Coral Gables Senior High School athletic complex; and

**WHEREAS**, the City Commission directs staff to re-allocate \$50,000 from the War Memorial Youth Center capital project budget to this endeavor; and

**WHEREAS**, the City will work with Miami-Dade County Public Schools to initiate an agreement for the long-term joint use of the re-designed facilities; and

**WHEREAS**, the re-designed Coral Gables High School Athletic Complex will provide the community with public access to recreational and athletic amenities including new renovated athletic fields, running track, basketball courts and restrooms.

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission directs City Staff to re-allocate \$50,000 from the War Memorial Youth Center capital project in the 2024-2028 Five Year Capital Improvement Plan to develop a conceptual design for potential improvements, including outdoor community recreation spaces, to the Coral Gables Senior High School athletic complex.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
