**RESOLUTION NO. 2010-167**

RESOLUTION AUTHORIZING EXPENDITURES IN THE AMOUNT OF \$20,840.00 FROM FEDERAL FORFEITED ASSET FUND (FAF) MONIES TO PROVIDE FOR THE ACQUISITION OF ADDITIONAL LAW ENFORCEMENT EQUIPMENT; THE HANDHELD RAPID ID DEVICES, AND THEIR ACCOMPANYING SOFTWARE LICENSES, SOFTWARE SUPPORT AND TRAINING, FOR UTILIZATION BY THE CORAL GABLES POLICE DEPARTMENT.

**WHEREAS**, The Coral Gables Police Department participates with federal law enforcement agencies of the United States Departments' of Justice, Treasury and/or Homeland Security in joint law enforcement operations, and the Coral Gables Police Departments' participation in those joint federal – local investigations produces federally seized funds; and

**WHEREAS**, at the discretion of the United States Attorney General under United States Statute: 18 U.S.C. Section 981 (e)(2), and 21 U.S.C. Section 881 (e)(1)(A) and (e)(3)(b), the Coral Gables Police Department may lawfully retain at the conclusion of the legal proceedings the federally seized funds; and

**WHEREAS**, the Interim Police Chief, Richard J. Naue Jr., and the Coral Gables Finance Director, Donald G. Nelson, attest to have deposited the sum of \$20,840.00 in said Federal Asset Forfeiture (FAF) funds into a special account; and

**WHEREAS**, the Coral Gables Chief of Police requests to expend these funds for use by the Department to acquire additional law enforcement equipment; and

**WHEREAS**, the Coral Gables Chief of Police certifies that the request complies with all provisions of the appropriate FAF statutory requirements as identified in the United States Justice Department's publication entitled "A Guide to Equitable Sharing for State and Local Law Enforcement Agencies"; and

**WHEREAS**, the FAF Committee met on August 16, 2010, and followed the FAF Committee operating procedures adopted on July 23, 2002, and approved the request to expend FAF monies as listed herein below in this resolution;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby direct the City Manager to authorize the Finance Director to expend \$20,840.00 from the Federal Forfeiture Asset Proceeds of the FAF to provide for the acquisition of additional law enforcement equipment; Handheld Rapid ID Devices, and their accompanying software licenses, software support and training for utilization by the Coral Gables Police Department. That this Resolution shall become effective upon the date of its adoption herein.

**SECTION 3.** That this resolution shall become effective upon the date of its passage and adoption herein.
