RESOLUTION NO. 2011-53

RESOLUTION RESCINDING THE AWARD OF THE SEGOVIA STREETSCAPE IMPROVEMENTS PROJECT TO MCBAYNE'S CONSTRUCTION AND RENOVATION, INC. PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED "APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS."

WHEREAS, on December 14, 2010, the Segovia Streetscape Improvements project was awarded to McBayne's Construction and Renovation, Inc.; and

WHEREAS, on December 15, 2010 a Notice of Award was issued to the contractor requesting performance and payment bonds as required under Section 2-1005 of the Procurement Code entitled "Performance and Payment Bonds; and

WHEREAS, a requirement of the Segovia Streetscape Improvements Invitation For Bid (IFB) 2010.09.27 were performance and payment bonds in the amount of one hundred percent (100%) of total project total, which in the case of this project would be \$696,262.50; and

WHEREAS, the contractor has failed to submit the require performance and payment bonds to the City; and

WHEREAS, under Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications," the City Commission, upon recommendation of the City Manager, has sole authority to rescind an award or terminate a contract in excess of \$100,000.00 for failure to submit required performance and payment bonds;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby accept the recommendation of the City Manager to rescind the award of the Segovia Streetscape Improvements Project to McBayne's Construction and Renovation, Inc. pursuant to Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications."

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


