A RESOLUTION AUTHORIZING THE CITY MANAGER TO ACCEPT
A GRANT VALUED AT \$5,875.00 FROM THE FIREMAN'S FUND
INSURANCE COMPANY HERITAGE PROGRAM.

WHEREAS, the Fireman's Fund has established a grant program that is referred to as the Heritage Program to help local fire departments; and

WHEREAS, the Fireman's Fund Heritage Program utilizes local insurance agents to direct grant opportunities to local fire departments; and

WHEREAS, the USI Insurance Services is a local insurance company that is the sponsoring company to facilitate the Fireman's Fund grant to the local fire department; and

WHEREAS, the City of Coral Gables Fire Department has been identified as the grant recipient for \$5,875.00; and

WHEREAS, the City of Coral Gables Fire Department meets the grant requirements as a local fire department and will direct the funding to purchase Ajax Rescue Tools air chisels that are utilized in extrication of victims of entrapment;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.




