Based on the below listed incident, I respectfully request to nominate the listed CGPD personnel for the below listed award.

On August 18, 2017 at approximately 0130 hours, while on routine patrol I was contacted by Officer Naya in reference to a traffic stop he had conducted. The vehicle Officer Naya stopped was occupied by two individuals (one male, one female).

Officer Naya advised the offender he had detained for no valid driver license was observed in the area of the 900-1100 block of Capri Street prior to conducting a traffic stop. Upon investigation, Officer Naya discovered the offender was on probation for prior burglaries in the same area. Officer Naya requested I go by the area (900-1100 block of Capri St) to see if there were any signs of vehicles burglarized. Upon checking the area, I did not discover any vehicles burglarized. I returned back to Officer Naya's location where he still had the vehicle stopped. Officer Naya felt there was more to the stop than a no valid driver license and continued investigating. At approximately 0220 hours, there was a report of a burglary in progress on the 1000 block of Granada Boulevard. Investigation revealed there were several vehicle burglaries committed on the 800 Block of Capri Street by multiple offenders that were related to the vehicle Officer Naya had stopped.

Initially when Officer Jorva apprehended the subjects, Officer Naya took it upon himself to contact him and ask for the names of the subjects. Further investigation revealed that one of the subject's that was apprehended by Officer Jorva, had left her driver license inside the vehicle Officer Naya had stopped linking the vehicle and the subjects to the burglaries. The vehicle and subjects were linked due to Officer Naya's investigative skills.

Officer Naya displayed exemplary investigative skills which linked the subjects to the vehicle he stopped and the burglaries. It is for this reason that I respectfully nominate Officer Naya for Officer of the Month.

NARRATIVE

On August 18, 2017, at approximately 0210 hours, I responded to 908 Granada Blvd reference a burglary in progress. Upon arrival, I made contact with the victim, who advised he witnessed two females enter his 2016, silver Buick Encore that was unlocked and parked in his driveway.

The victim advised he was getting a drink of water in his kitchen when he looked out of his kitchen window and saw Offender 1, Ms. Mirella Alessandra Gray, and juvenile Offender 2 inside of his vehicle. The victim advised he saw offender 1 wearing a black shirt and was sitting in the driver seat of his vehicle. The victim advised that offender 2 was wearing a dark colored shirt and was sitting in the rear driver side of the vehicle. The victim then went outside and confronted offender 1 and offender 2 and asked them what they were doing, which they responded, "Spraying the car so it smells nice." The victim advised they had a "Glade" air freshener can in their possession at the time of the incident.

The victim stated he stood next to offender 1 and offender 2 by his vehicle to try and get ahold of his wife, who was inside of the residence, to call the police. He could not get her attention due to leaving his phone inside, and decided to walk toward his front door to get her. As soon as he walked away from the offender 1 and 2, he advised they began to run northbound on Granada Blvd toward SW Eighth Street. The victim stated he ran after them but stopped at SW Eighth Street after they began to run eastbound. The victim then went into his residence.

Coral Gables Police units were dispatched and canvassed the area for the offenders from the BOLO description given by the victim.

At approximately 0220 hours, Officer Jorva (10179) observed two females matching the BOLO description at 800 Capri Street in the parking garage area. Officer Jorva made contact with the offender 1 and offender 2 and detained both subjects for further investigation.

A show up was conducted by Officer Aguirre (10575), to which the victim positively identified both offender 1 and offender 2 as the two subjects he saw inside of his vehicle. At that time, offender 1 and offender 2 were arrested for burglary to a conveyance.

Offender 1 was transported to TGK via CGPD processing. Offender 2 was transported to the JAC via CGPD processing.

Officer Grigg (10536) responded and processed the scene.

Post Miranda, Offender 3, Mr. David Melendez, admitted to Detective Baserva (8408) and Detective Garcia (7615) that he dropped off offender 1 and offender 2 in the area to commit vehicle burglaries.

This case can be cross-referenced with Coral Gables Police case number 17005804 and 17005802.

I was dispatched to 908 Granada Blvd reference two females offenders (Mirella Alessandra Gray & Katrina Gomez Isabel) who were witnessed by the victim, breaking into his vehicle. CGPD dispatch advised , both offenders had fled on foot northbound on Granada Blvd towards Eighth St. At the time of the call, victim gave a brief description, describing offender (Mirella Alessandra Gray) wearing black top and black pants and offender (Katrina Gomez Isabel) having light colored hair.

While driving in an unmarked Police K-9 vehicle, I conducted an area search for the two female subjects. While on Eighth St, I observed the two offenders in the ground floor parking of an apartment building located at 800 Capri St. walking around parked unattended vehicles. I then observed the offender (Mirella Alessandra Gray) walk up to a Black Toyota Yaris (FL Tag: 027VHK) and attempt to open the right rear door with no success. The offender then walked to the next parked vehicle, a White Ford F-250 truck (FL Tag: GZQC96), where I then observed the offender open the right rear passenger side door and rummage inside.

I then proceeded to drive my vehicle to the east side of the parking lot in order to make contact with the offenders. At which point, both offenders were located on the right side of a Nissan Pathfinder (FL Tag: HHEE26). The Nissan Pathfinders interior lights were on and the inside of the vehicle was rummaged through. The White Ford F-250 rear tailgate light was also on.

Both subjects were taken into custody and seperated. Contact was made with the owners of the vehicles.

Shortly after, two white females matching the same description given by the caller were observed by a CGPD unit, entering several other vehicles inside the private parking lot located at 800 Capri Street, and proceeded to stop them at this location. Both female subjects were arrested and transported to CGPD for interrogation. One female was Mrs. Gray and the other was a juvenile.

Simultaneously, another CGPD unit observed a suspicious vehicle drive through the area of Mariana Avenue and Capri Street, without working break lights. The vehicle was a 2005 black Nissan Altima, bearing FL tag T442TY, and was driven by a male driver, Mr. David Melendez, with a female juvenile passenger. The vehicle was stopped for investigation leading to the arrest of Mr. Melendez for not having a valid driver's license. During the investigation, it was revealed that Mr. Melendez had dropped off the other two female and was going to pick them up when requested. Mr. Melendez and juvenile female passenger were arrested and transported to CGPD for interrogation.

At CGPD, Sgt. Garcia (K600) and I interrogated the three female subjects and the male subject. The interrogation revealed that all four subjects drove together to the incident location in the black Nissan Maxima. Mr. Melendez indicated that he had knowledge that the crimes were going to be committed and that he dropped the two females off and was waiting to pick them up after they went "carhopping". Mr. Melendez Teletype check revealed that he was arrested in the past by CGPD for vehicle burglary and that he was on probation.

During the interrogation, the female juvenile passenger indicated that she had no knowledge that the crimes were going to be committed. There was no indication found that she was aware that her friends were committing the crimes or that she committed any crime herself. She indicated to be homeless and to have no family locally, therefore the Department of Children and Family was contacted and took custody of her.

The other female juvenile subject and Mrs. Gray were also interviewed. During the interview they both admitted breaking into the vehicle at 908 Granada Blvd and three additional vehicles parked inside the private parking lot at 800 Capri Street. They both indicated that they were dropped off in the area by Mr. Melendez to go "carhopping". They

both advised they walked to 908 Granada Blvd and opened the unlocked vehicle. They both indicated that Mrs. Gray entered the vehicle and sat on the driver side seat, searching for valuables. There were no valuables inside. They also indicated that the vehicle owner exited his home and confronted them before they fled the scene. Both females advised that they ran toward 800 Capri Street where they entered the private parking lot. They advised that once inside the parking lot they opened three additional vehicles and search for valuables. Both females admitted that they went to the area in order to go "carhopping" and checked several vehicles for valuables. Nothing was taken from any of the vehicles by the subjects.

All three females indicated to be homeless. They do not have any criminal history.

Mrs. Gray and her female accomplice were arrested for Burglary of an Unoccupied Structure, and Vehicle Burglary.

Mr. Melendez was arrested for Vehicle Burglary and No Valid Driver's License.

The black Nissan Altima was towed and put on hold for investigation.
