An Ordinance of the City Commission of City of Coral Gables, Florida approving a purchase and sale agreement with Riviera Presbyterian Church for the purchase of a portion of the surface parking lot at 1325 Sunset Drive, Coral Gables, FL, also referred to as 5275 Sunset Drive (the western portion of Folio No. 03-4130-009-3240) for the purpose of establishing a firehouse and park using State of Florida grant funds for a portion of the purchase; waiving certain requirements pursuant to Section 2-1089 of Division 12 of the Procurement Code; providing for severability clause and providing for an effective date.

Mayor Valdes-Fauli: F-1.

City Attorney Ramos: F-1 is an Ordinance of the City Commission of City of Coral Gables, Florida approving a purchase and sale agreement with Riviera Presbyterian Church for the purchase of a

portion of the surface parking lot at 1325 Sunset Drive, Coral Gables, FL, also referred to as 5275 Sunset Drive (the western portion of Folio No. 03-4130-009-3240) for the purpose of establishing a firehouse and park using State of Florida grant funds for a portion of the purchase; waiving certain requirements pursuant to Section 2-1089 of Division 12 of the Procurement Code; providing for severability clause and providing for an effective date. This is a public hearing item and it must be adopted by a four-fifths vote.

Vice Mayor Lago: Good morning.

Ms. Sardinas: Good morning Mayor and Commissioners, Zeida Sardinas, Asset Manager, Economic Development. The item before you today is for approval of Second Reading of the Purchase and Sale Agreement between the City and Riviera Presbyterian Church, for the purchase of a portion of the parking lot at 1325 Sunset Drive, also known as 5275 Sunset Drive, for the purpose of establishing a firehouse and park. The City finalized the Purchase and Sale Agreement between First and Second Reading and in accordance with the term and conditions that were spelled out during First Reading, and the PSA was distributed to you yesterday and has been made part of the record. Rank documents have been provided to the State of Florida, staff is pending Commission approval of the PSA on Second Reading today to provide the executed PSA to the State and begin its due diligence process for the purchase. Staff continues to recommend approval and to answer any questions you may have.

Fire Chief de la Rosa: As I stated before, this property meets our objectives to address our challenges between Fire Station No. 2, which is on Riviera Drive and Station 3, which is on Old Cutler and Red Road. This site is suitable for that and it gives us the access that we've been looking for, for a while.

Mayor Valdes-Fauli: You can park in the back.

City Manager Iglesias: Mayor, Commission, this site is ideal for what we've been looking for, its zoned special use, its zoned residential, its adjacent to the school, a daycare center and the Coco Plum Women's Club, and which they use for weddings and so forth. Its also a current parking lot, and it will be transformed into a firehouse, which will be, which will look like a residence. We plan on placing the firehouse park. We plan on placing a firehouse park behind adjacent to the residential and what the residents will be looking into, a parking lot will be a playground and a residential-looking structure. The Fire Chief has gone...morning and afternoon and he feels that this site can really help us as far as cutting down response times and really saving lives. So, I think it's a great project and I'm looking forward to signing that contract, that PSA and sending it to the State today.

Mayor Valdes-Fauli: Thank you. This is a public hearing, we have one person who wishes to speak, Rip Holmes.
